# BOARD MEETING

## April 25, 2019

## CALL TO ORDER:

Buildings and grounds was taking estimates for new retaining wall at the Pavilion. Estimates should be in the office.

Small Excavating machine was rented from Laurel Oak Landscaping.

For sale sign was moved from the new monument site.

All wood was moved from Monument site.

Pavilion boat docks were all floated into the water.

Buildings and grounds is working on the Pavilion boat docks. Going out ASAP and should be ready for boats May 1<sup>st</sup>. Boat slip applications can be found in the office.

Cleaned up the small wooded area between ramp 5 and ramp 4 along 121 and the walking path. Replacing deck railings at the Pavilion. Starting demo of old wood as of today 4-23. New wood ordered for delivery.
