Mr. Cassidy reported the following:

The office would like to place a full page ad in the Journal for the North Salem Volunteer Ambulance Corp. 2014 Winter Gala. The cost is \$100 and is considered a donation. Mr. Cassidy made a motion to place this ad. Ms. Myers seconded. All in favor. Motion approved. The 2014 Directory is printing now and will be mailed out at the beginning of January. The office will be closed Christmas Day and on December 26 and 27th, and then again on New Year's Day.

BUILDINGS & GROUNDS:

Ms. Waltzer reported about the new woodwork in the large room and how fabulous it looks. Some minor touch ups need to follow. We are currently working with our snow plow contractor to correct any issues with snow removal. There has been an issue with picking up sand/salt at North Salem, as the workers are on the roads working. Mr. Hartschorn just needs to contact the Building Department to let them know he is coming. Ms. Myers complimented Mr. Hartschorn and stated that she thinks he did a fabulous job during the snowstorm. Mr. Cassidy agreed as well, as did the rest of the Board. Ms. Waltzer reminded people not to use Ramp 3 during snow. She suggested that everyone use Ramp 1 during bad weather. Mr. Cassidy stated that Mr. Hartschorn now knows that there are parking areas which need to be plowed as well and that he did take care of those during the second snow. Mr. Ryan asked Ms. Waltzer to have some of this above information in with the January mailing to remind residents about some of these safety issues.

PUMP HOUSE/WATER TANK REPLACEMENT:

Ms. Waltzer stated that the bids were open and they were higher than we had thought. These bids were reviewed with Paul Lynch, Engineer. The low bid was \$530,000 and the high bid was in the \$700,000's. Mr. Lynch took the bids to compile everything on a spreadsheet. The low bid was Foley, who has a very good reputation and is well known in the Grove. John Lee highly recommended them as well. Paul Lynch would now like to meet with Ms. Waltzer and Mr. Lee to see if the price could come down a bit. We are looking at steel tanks and fiberglass tanks. Some of the bidders charged more for the steel tanks and some charged less. Foleys would charge less for the steel tanks.

Mr. Duffy asked how we pay Mr. Lynch. Ms. Waltzer stated that we receive a bill from him each month for plans, revisions, etc. We do not know how much we will be charged by Mr. Lynch for the overseeing of the construction. Mr. Ryan and Ms. Battreall both think that Mr. Lynch would be finished once we award the contract and then Foley would be the General Contractor on the job. Ms. Waltzer will verify that information.
