CALL TO ORDER:

COMMUNICATIONS NOT INCLUDED IN REPORTS BELOW:

Ms. Waltzer discussed the issue of the damaged roots on the tree on the property of Marie Fagan on Orchard Road. Ms. Waltzer would like a letter sent by Ms. Vail to Joken Development and GHD informing them that we feel they are responsible for the damage. This damage was caused when Joken was installing the sewer equipment. If this tree does fall, it would damage homes across the street. Ms. Myers stated that Joken/GHD has already set a precedent; when they severed the roots of a tree by her house, they took it down and they paid for it. Ms. Waltzer made a motion to have a letter sent by our Legal Counsel. Ms. Myers seconded. All in favor. Motion approved.

BUILDINGS & GROUNDS:
Ms. Waltzer stated how pleased she is with the way Mr. Moore is doing his job. He is following up with calls and issues he needs to look into and then he discusses issues with Ms. Waltzer. She also stated that she has a lot of confidence in Mr. Moore.
Mr. Moore then gave the B&G report:

The generator variance was approved at the town meeting. Work will be starting on Monday. The generator has been delivered. When the warmer weather comes, the cement pad will be able to be put in.

The Pavilion has had some windows remodeled with new casings and trim. Jay is working on fixing many cracks and holes in sheetrock and walls. The Pavilion will then be painted. When the Pavilion is rented, we will be tougher on people regarding putting things on the walls. The contract does state that renters cannot put anything on the walls and if need be, we will keep security money for repairs.

The lawn contract bids have gone out. Ms. Waltzer made a motion to accept the bid from Salem

Landscaping. Mr. Andrews seconded. The charge will be \$365 a cut and the leaf clean-up will be \$4500.

Hopefully, this will all be completed by the end of March.

We have spoken to 3 propane companies to get the best prices for propane. As of this writing, only 1 has submitted anything in writing. We hope to have another in so we can make a decision soon. Leahys supplies Pavilion for \$2.49 and Suburban does pump house for \$2.29. Jay asked Leahys if they would match Suburban's price and they said they would do all three tanks for the \$2.29 for one year contract.

Note for minutes: A motion was made by Ms. Waltzer to have Leahys fill all three of our tanks. Ms. Enos seconded. Discussion was had. We would like to be able to have Leahys offer the same price to homeowners. The tape does not reflect that a vote was taken on this issue.

Mr. Moore has been speaking with swing set companies. It appears that these companies do not want to repair the set as it is very old, so we have gotten prices to replace the swing set. One price was \$2800 and another was \$6900. Mr. Moore is still trying to get more prices and then we could go back to the insurance company to see if they will cover a new set.

We had received 2 prices for the north end emergency road job. One price was \$6500 and one price was \$5800. Ms. Waltzer made a motion to award the road building to Butler for the price of \$5800., for excavating and putting in new item 4 and compact it, and they will remove any shrubs/bushes in the way. This road will be for emergency use only. It will be a 6" gravel road. Ms. Myers seconded. All in favor. Motion approved.

PUMP HOUSE REPLACEMENT:

Ms. Waltzer stated that Putnam Engineering will apply for site plan approval for the new pump house at the Southeast Town meeting on February 19, 2013. The work continues on construction plans to be presented at additional Southeast town meetings. In the meantime, Putnam Engineering continues to bill us for their work on a monthly basis.
