BOARD MEETING

November 15, 2018

CALL TO ORDER:

Mr. Cassidy called the meeting to order at 8:05 pm and asked all to rise for the Pledge of Allegiance.

ATTENDANCE:

Mr. Duffy took attendance. Present: Mr. Andrews, Mr. Cassidy, Ms. DiDomenico, Mr. Duffy, Mr. Janecek, Mr. McGuinness, Ms. Myers, Mr. O'Toole, Mr. Sarno and Mr. Waltzer. Absent: Ms. Salerno, Mr. Cammisa and Ms. Rubini.

ACCEPTANCE OF MINUTES:

Ms. Myers made a motion to accept the minutes of the October 2018 meeting. Mr. Andrews seconded. All in favor.

SECRETARY:

The Directories are ready and here in office. Final cost was a little over \$700 and there is over \$300 left. The office is thinking of mailing them with the January billing, Vails Voice, tax and budget letter, as the postage is covered by the ads. By-laws and Rules and Regs are in there as well this year.

The Office has been very busy assisting David Janecek with his work on possible cost cutting and possible revenue income. Lots of financial information has been requested and various reports have been sent and questions answered

We have multiple sales of homes in process right now.

The office will be closing for the entire Thanksgiving week.

The signatory forms are now in place with M&T bank for the Executive Board. Surveys have been coming into the office as requested. Reminders will be sent out in December. Office investigating cost to place an additional camera facing the front door of the Pavilion.

TREASURER/FINANCE:

Mr. Waltzer made a motion to approve the budget for 2019 as presented and raise stockholders quarterly maintenance fee by \$50 per quarter. Ms. Myers seconded. In favor: Mr. Duffy, Mr. Sarno, Mr. Waltzer, Mr. O'Toole, Ms. DiDomenico, Mr. Andrews. Against: Ms. Myers, Mr. McGuinness, and Mr. Janecek.

INSURANCE:

SKCG will let us know when the final 2019 costs come in.

BUILDINGS & GROUNDS:

Buildings and grounds assisted Mr. Duffy and Mr. Andrews with a large tree branch at the new Monument site.

Pruning and weeding of Koestler's Garden was finished.

In the process of clearing roadside drains and basins.

Machine is rented to take out the Pavilion boat docks.

Vail's Grove maintenance truck was in for safety state inspection and truck passed all inspections.

Finally I can report that all curbs that were destroyed from snow plowing last season have been repaired along with some minor road patching.

The tree that was reported in bad shape on Terrace Drive has been taken down by Salem Landscaping.

NYSEG has been called for the removal of the cables in the tree between 95 and 93 Vails Lake Shore Drive. To date nothing has been done. I was assured the process is being taken care by NYSEG.

Continuing daily curbside pickup weather permitting. Reminder that paper Leaf Bags can be found at the maintenance garage during the day.

A call from Bill Colavito resident on Lakeshore Drive with concerns about his water shut-off valve lid. Buildings and grounds was able to locate a spare and problem resolved.

Storm drain repair on Locust and Polye. Approximately 26 ft. of storm drain was repaired. This was just an old deteriorated pipe. Repairs were made by Butler Excavation.

Working in the North End boat storage to maximize efficiency. Just keeping organized. Buildings and Grounds, Mr. Andrews, Mr. Duffy, and Mr. Cammisa have all walked the properties behind Locust concerning the water issues. A co-op drain pipe is being investigated to whether it's properly taking water. A homeowner's drain pipe is being investigated.

After discussion, it was requested that letter/emails be sent to both the Sowas and Bri Kane about the outcome of B&G investigation.

Revenue/Expense Motions

Motion 3

Mr. Janecek made a motion to instruct the office manager to mail out quarterly charges twice a year. The notice will contain 2 quarterly payment coupons. By doing this, VG will reduce its postage expense from an average of \$2500 a year to less than \$1500. Effective date 1/1/19 or sooner. Ms. Myers seconded. All in favor.

Motion 4

Mr. Janecek made a motion to switch 2019 pay dates from 52 weekly pay dates to 26 bi-weekly pay dates. This will save the coop an estimated \$1000 per year. Additionally, the office manager is requested to seek payroll processing bids to see if further savings can be found. Effective date 1/1/19 or sooner. Ms. Myers seconded. (2-3 bids)

Motion 5

Mr. Janecek made a motion to implement the following: VG directs the B&G department to place lock boxes over the thermostats in the Pavilion and set them to an appropriate temperature for the standard M-F work day (per OSHA employers should maintain workplace temperatures in the range of 68-76 degrees F.) Additionally, B&G to ensure that the heat is turned down when the building is not being used and the AC is turned off when the building is not being used or sections of the building are not being used.

5c. VG board directs the office manager to provide key to the lock boxes (contingent to rental agreement and receipt of security deposit) to all renters. Keys must be returned to receive deposit back. Further authorizes the office manager to make this change to any existing rental agreement contracts.

5d. VG board instructs the office manager to request propane pricing from local suppliers to see if more cost effective suppliers are available. Effective 1/1/19 or sooner. Ms. Myers seconded. All in favor.

Motion 6

Mr. Janecek made a motion for the B&G committee to change the lawn cutting bid sheet to specify that all lawns are to be cut every other week with the exception of the playground, pavilion, 6-car garage and beach. Additionally, B&G to acquire a minimum of 7 bids to have the RFP considered a valid response. Effective immediately. Ms. Myers seconded. All in favor.

Motion 7

Mr. Janecek made a motion that based on accounting records, it costs on average of \$7000 to install community docks each year. About 20 households take advantage of dock space that VG supplies. As such, the following authorizes VG to charge for dock spaces:

1-12 feet \$100, 12-19 feet \$250, 20 feet and above \$300. Storage on land adjacent to the shore for non-power small boats/kayaks will remain no charge. It shall be at the sole discretion of the Board as to what fee applies. All funds collected shall be turned over to the office manager and

recorded as revenue. Effective March 2019 or the 2019 boating season, whichever comes first. Mr. Andrews seconded. All in favor.

Motion 10

Mr. Janecek made a motion for the following change to be made to the conduct rule to prohibit stockholders from harassing employee. Change to: 2. Conduct: A stockholder, stockholder family, guest or agent shall not interfere with, harass or be physically /verbally abusive to any VG employee. Mr. Waltzer seconded. All in favor.
