

The July Heat is on and our Towns deliver for Peach Lake - Peggy Boyle

Peach Lake Coalition members met with Supervisor Paul Greenwood and Supervisor Michael Rights on July 16th as the fast approaching deadline of July 25th for the Environmental Facilities Corporation (EFC) application for financing was upon us. This financing is necessary to keep the project affordable to shareholders. Coalition leadership had contacted Fred Testa of EFC, prior to the meeting, and he promised to list for each town in a letter what remained to be submitted in order to be considered by the EFC board for approval. His detailed letters were used as the agenda for our meeting.

The most difficult requirement was the written approval from NYS Comptrollers Office in Albany to form the sewer districts in each town. All documentation was submitted to Albany and there was a 15 day period of review for each County that had to expire before Albany could issue the approval. That period of review would end on July 18th but it seemed that the process was moving slowly. Without the official approval from Albany, the two towns could not meet to pass the necessary resolutions that were required to be part of the application packet to EFC.

An intensive effort was undertaken by both Town Supervisors, both Town Attorneys and the Peach Lake Coalition to complete all the tasks in time. Pressure was put on Albany to get the formal approvals signed by the Deputy Comptroller and delivered to the towns.

On Friday, July 18th, North Salem received formal approval to form the North Salem Sewer district and the following Tuesday, July 22nd, the North Salem Town Board passed the resolutions. The full packet including those resolutions was received by EFC on the 24th.


The Town of Southeast received formal approval to form the Southeast sewer district on Wednesday, July 23th in the late afternoon which was in time for the Southeast Town Board on Thursday, July 24. The Southeast Town Board voted unanimously to pass all the resolutions related to Peach Lake in time for meeting the deadline of the following day, July 25th.

All in all, great teamwork produced great results.

The EFC board will review our application for no interest short term financing and low interest long term financing this summer and issue approval in September.

Vail's Grove Announces the "Adopt a Garden" Program Brought to You by the Aesthetics Committee





During these long, hot days of summer, it happens occasionally that our gardens need a little extra loving care in the form of water. The mailman needs to be able to pull in, deliver mail, and then pull right out. Thank you for your cooperation!

If you are donating or returning books, please do not leave them in front of the office door, as they can get wet or damp, and then get ruined. Please return them during office hours.




Locks at Boat Ramp and Boat Storage Area Changed New Rules & Regulations Under Review

In an effort to keep Peach Lake free of barnacles, troublesome bacteria or other problems caused by moving boats in from other lakes, a Committee has been formed to create a new process for Vail's Grove residents to get their boats in and out of the lake, as well as the storage area. In anticipation of the new process being reviewed and, hopefully, approved by the Board of Directors, the locks at the gates to the Boat Ramp and the Boat Storage area at the North End were changed this week.

The new Rules and Regulations for gaining access to the Boat Ramp and the Storage Area, to be reviewed and voted on by the Board of Directors at the August 20, 2008 meeting, are designed to ensure convenient and safe boat storage and water vehicle use for all Vail's Grove shareholders.

Shareholders needing access to the Boat Ramp or the Storage Area in the interim must call the office to arrange an appointment to have Buildings & Maintenance personnel meet them to provide access to either locked gate. Please call Cindy at (914) 669-5100 to make an appointment.
