Pump House Update From Ronnie Waltzer

Vail's Grove wants to thank and acknowledge Ken Sullivan's generosity for replacing our very leaky pump house roof. He supplied the crew, their time, and all the materials for the job at no cost to Vail's Grove. Thank you, Ken!

The DOH made the final inspection at the Pump House, and although we passed, there are a few items left to complete. The contractor must apply the insulation to the inside walls; some grading of the property must be completed; and an inservice to update shareholders who have volunteered to check the Pump House's new equipment is to be scheduled. We will make our final payment when all is complete.

Peach Lake Environmental Coalition (PLEC) Update for December 2014 Prepared by Pat Ryan

Many of the residents around the lake have commented on how clean the water is now that the Sewer Treatment Plant is fully functional and the aging septic systems are no longer in use.



Phosphorus buildup contributes to algae blooms and an increase in weed growth, but this past summer season there appeared to be a reduction in these which contributed to

the enjoyment of the lake.

The best PLEC news of the year came from Warren Lucas, our North Salem Town Supervisor, in late October. "I was just told by Assemblyman David Buchwald that Governor Cuomo just announced that Peach Lake received the grant for \$450K for Water Quality Improvement through the water quality improvement program run by NYWorks via the DEC." This grant, at the suggestion of PLEC, was based on the "Peach Lake Stormwater Pollution Study" conducted in 2008. The primary contributor to the buildup of phosphorus in Peach Lake was determined to be the aging septic systems. This was remediated by the new Sewer Treatment Plant. The study also



concluded that the water runoff from surrounding areas of the lake is contributing to phosphorus buildup. The study indicated that phosphorus reductions could be achieved by the use of proprietary treatment units within limited areas such as Right-of-Ways where runoff water could be captured and treated prior to drainage into the lake. Future updates related to this grant will be forthcoming in the new year once PLEC is able to meet with Warren Lucas and Tony Hay to better understand the process.

PLEC is researching how horse farms and golf courses are regulated to provide proper handling of horse manure and fertilizer. Poor handling will contribute to a buildup in phosphorus since the runoff from these farms and golf courses eventually drains into Peach Lake.

The new name for our PLEC organization which replaces the word "committee" with "coalition" was approved by New York State. The bylaws were also updated and approved by the PLEC voting members.

There is an ongoing assessment of the outlet at the north end as it can cause flooding of the lake if water cannot exit properly to the reservoirs. Periodic inspections are taking place to insure no large objects such as row boats or docks are obstructing the flow of water.

Please be mindful of leaving debris on the lake once it freezes. Everything left on the frozen lake will become part of the lake once it thaws. Please leave the lake as you found it so that all can enjoy this beautiful natural resource.
