- All dogs, regardless of size need to be on a leash and under the full control of the person walking the dog. Keep in mind that not everyone is a dog lover and some people and children may be frightened by your dog.
- You, the homeowner are responsible to maintain the land that your home is on; please keep your grass cut and your property looking nice. No one wants to live next to a junk pile.
- Please try and resolve issues between neighbors ourselves; respect and a conversation might just resolve the issue, BEFORE you need to contact the office for assistance.

Pump House From Pat McGuinness

Thanks to the continued monitoring by VRI of our water supply and equipment for such, our pump house remains problem free. All safety guidelines and tests are strictly followed, keeping our water safe for all. In addition to the efforts by VRI, we are also having our water tanks inspected and cleaned hopefully in late fall when water usage reduces. This is a service that is recommended to take place every ten years. We anticipate no problems to be reported, fingers crossed. In the grand scheme of things, our tanks are considered still relatively "new", but we are having this operation performed regardless. The company that has been selected by the Board of Directors has assured us that there will be minimal, if any, interruption to our water service during this operation.

On a side note, not exactly related to the Pump House but rather to our own individual water supply to each home here in the Grove, we have been tasked by the NYSDOH, as have ALL water systems in NY State, to provide the following information which is DUE to the state by OCTOBER 15th,2024.

Please review this correspondence from VRI, which they received from the New York State Department of Health: The NYSDOH Lead Service Line Inventory is due for all water systems on October 16th, 2024. This comprises of a list of every service connection within the water district, and the composition and size of each service line of both the public and privately owned sides (before and after curb box valve). The State is requiring some type of proof by way of building records, pictures from homeowners, excavation & individual inspections, etc.


The easiest and most cost-effective way to complete this is by proving the water service connections were installed after the Lead Ban in June of 1986. If the service connections were installed before 1986, we can potentially use building records/maps which indicate the service line composition and this would be useful information as well. If these records are not accessible or do not exist, we will have to determine the best way to identify the service line material for each water service connection. If you do happen to have building records, maps, etc., please send over this information as soon as possible so I can get a head stat on this.

So, to reiterate, we must supply NYS with proof of how our water is being supplied to each house. Lead has been banned here in NY so we must comply to prove we have no lead that was used after 1986. We realize that most of the homes here in the Grove were constructed prior to 1986, however, with the introduction of the Water Treatment Plant, we are quite sure that there will be no lead pipes supplying water to our homes. But, unfortunately, NYS will not just take our word for it. Several members of the board of directors, one volunteer neighbor and VRI met to discuss the best way to attain this information. Here is what we have come up with.

In an effort to get this information to VRI as quickly as possible, we are requiring all residents to do the following:

Please take a photo of where your main water line comes into your home. (Please see photo examples below)





These photos were taken in the basement of a home here in Vails. You'll notice that the Water Meter for the home is very near the main water supply. The supply for this house is rubber. This is all we need. Once this photo (or photos) is taken, they will need to be sent to the office. In addition to these photos, we will need YOUR NAME AND HOME ADDRESS in the body of the email. These photos were taken with an Iphone, the images uploaded

to the email of the owner and then the owner forwarded the photos to the office along with name and address of where the photo was taken. This information will then be forwarded to VRI who will be compiling a list of everyone's information to meet the deadline set by the NYSDOH. We need to acquire this info AS QUICKLY AS POSSIBLE. We are asking that everyone please take the photos now so that this list can be started and completed well prior to the NYS due date.

For those of you who do NOT have such easy access to your water main to take a photo as shown above, please send an EMAIL to those of us listed below. One or more of us will be in contact with you over the next couple of months to see how best to get your photo taken or find another way to confirm how your water is entering your home.

Once again, this is NOT a Vails Grove operation, this is a REQUIREMENT by NYS that we MUST adhere to. We are not certain as to what ramifications may lie before us if we do not supply this info in a timely manner. So, the sooner we get these photos the better so that any inconveniences and trouble spots can be identified, discussed and remedied PRIOR to the deadline.

We appreciate everyone's cooperation in this endeavor. We will do everything in our power to make sure this all goes as smoothly as possible, but YOUR COOPERATION IS CRITICAL. We are not looking to inconvenience anyone. We ALL MUST take part in this and see it to its completion so your patience and understanding will be greatly appreciated.

Boat Ramp/North End Storage From Pat McGuinness

Thanks to all of you who made the transition from land to sea with regards to boats, jetskis and such from the North End go smoothly and with minimal discomfort. Despite a few hiccups of blocked boats and trailers here and there, thanks to you, these were resolved quickly. Please note that your communication and willingness to resolve any issues makes ALL the difference. However, there are still a few things to address. To no ones fault, many of the 2024 stickers which had a number written on them with a marker faded and we were unable to identify who owned what. Next season, we will be issuing stickers with pre-printed numbers on them to prevent this from happening again. The board also discussed possibly adding a scannable QR code to the sticker supplying the name and number of the owner in case someone is blocking you. This would eliminate having to write your information any where but you can certainly still do that, in fact it's encouraged. The more accessible information we have the better. Hopefully, this can further assist in expediting a quick resolution to any problems as far as blockage and the like. A reminder that all dues must be paid prior to return storage for the following year. All equipment not properly tagged and filed with the office will be subject to a fine which we want to avoid at all costs. We also ask that anyone who still has property in the North End that is absolutely not usable anymore, please find a way to remove such property so that we can make room for more vessels if needed or to just make more room for those already utilizing the North End.
