
WHAT IS AN OMBUDSMAN?

The name "ombudsman" (om budz man) comes from Swedish and literally means "representative." At the most fundamental level, an ombudsman is one who assists individuals and groups in the resolution of conflicts or concerns. There are a number of different titles or names for this position: "ombudsman," "ombudsperson" or "ombuds" among others.

What is the role of Ombudsman, as a Board member of the Vail's Cooperative?

The Ombudsman works hard to resolve issues that come up between neighbors, while remaining neutral (Not on any one side) yet must always adhere to the rules and regulations of the Coop. Many believe that this position is a thankless one and in a way it is, however, I



believe it to be very important to try to resolve issues and concerns between neighbors before it goes to what ever the next level is. Let's face it, most issues fall within the classification of "typical" neighbor issues and can easily be worked out to the relief of both parties. On occasion, there could be a difference in opinion as to the how each party views a "rule or reg", etc....those kinds of decisions do go to the full board so that the answers to those questions remain constant and equal. The board does not takes sides. We are all volunteers trying to the best of our abilities to ensure that the Vails Cooperative Board of Directors remains true to the flavor of our community while following the rules and regulations. BUILDINGS & GROUNDS

The Grove is looking really good in preparation for a busy spring and summer (if it would only stop raining for 5 minutes). Newly built boat slips at the pavilion marina offer additional space for all Vail's residents. Don't forget to submit your application to the office.

The new generator at the pavilion is connected and can be up and running for power failures in the Grove. The propane tanks to power it have been buried behind the flag pole in the monument garden. In emergencies, residents can get warm, or cool off, and power up their phones, i-pads, and other devices. Your Board of Directors made this possible!

As a reminder, remember that only grass cuttings can go into paper leaf bags. No black plastic bags will be picked up. Branches must be cut into 4 ft lengths and left at the curb.

A newly constructed emergency road has been built to run from the field across from the tennis courts, up the hill to the access road for the WWTP. This road will be opened for emergency use only, ie trees or fallen telegraph poles blocking current access routes. A chain with locks blocks the road at each end. A list of people with keys will be posted in the window of the office.

And another thing.....don't throw anything down your toilet that you haven't eaten first!!! No baby wipes, diapers, tampons, etc. The blade on the grinder pump is small and will clog trying to chop up unsuitable items. Repairs are expensive. Everyone was sent a list with the phone numbers of whom to contact in an emergency.

For those of you needing information about trees on your property in need of tending, there is a list of tree people and arborists in the Office.

No one should be using a dry well for grey water. These were all to have been discontinued when the grinder pumps were installed.

> Last, but not least, people are still speeding through the Grove. The speed limit is 10 mph. Keep our children safe!!!!.


BEACH

AN IMPORTANT MESSAGE FROM TOWN SUPERVISOR, WARREN LUCAS

I would like to make you aware of a couple of things and hopefully you could let people know also. We will send a pamphlet out before July. In fact I would love to have anyone interested help out on the content.

There were items that we asked people not to throw down the toilet. One of them was baby wipes. For whatever reason these have polymer based material in them that the grinder pumps macerate but that do not break up. We had a problem this week with a clog in a low pressure line and a large number of grinder pumps could no longer pump their effluent into the line. VRI opened and cleaned the line, which took a few hours of work with trucks to pump manholes out. They found that a number of baby wipes had caused the clog. Service was restored. Cost about \$1000

We also have had people driving over the new sewer curb cocks. Please do not do that as it potentially can break the sewer line if you do. That has happened a couple of times already and to dig it up and replace the line and valve costs as much as \$2000.

Please know that when VRI does this type of thing it is on an hourly cost to the district. The recent tax bill had \$394.20 in it to operate the plant and do maintenance. Spending the money on these types of things is a waste. We know things do happen and things do break but please be as careful as you can.

Do not dump oil, grease, paint, strong chemicals, sand, kitty litter, etc. down your drain. Feminine products, baby wipes and other personal/cleaning wipes should be disposed of in a garbage can. These items should not be introduced into the sewer system. They can damage or cause premature problems (parts wearing out) with your pump, or build up in the tank and prevent your pump from working properly. And don't forget, any money that gets spent is money that is coming out of the pocket of everyone in the district.

The work on landscaping is ongoing. Thank you all for your patience.
